MATTERS RELATED TO THE CITY

Mosquitos

Whilst there are a few mosquitos around at present the City should be congratulated for its efforts in keeping mosquito numbers to a minimum over summer. It acknowledges that the weather was a great help. The absence of mosquitos makes outside activities so much more enjoyable.

Stormwater Sumps

The City should also be acknowledged for its initiative in contracting "Environmental Services" to pump out all the stormwater sumps that discharge directly into the Port Mandurah canals. This activity ensures that pollutants and sediments that have collected in the sumps over summer do not enter the canals when/if it rains.

Street Rubbish Bins

In the area assigned to the Port Mandurah Residents' Association for the Clean-up Mandurah Campaign (the triangle encompassed by Old Coast Rd, Mary St and McLarty Rd) the City has replaced most of the original circular street bins with Sulo bins similar to those provided to residents. This made the bins easier to empty, provided greater volume and a lid that prevents animals pulling rubbish out of the bins.

However, this initiative has been rendered largely ineffective by "weekend" residents who have taken advantage of the larger bins to dump their household rubbish before they return home, rather than arrange with a neighbour to put their bins out on the designated day. The result is that the street bins are now overflowing at the end of the weekend, preventing their use for genuine litter disposal and allowing seagulls, ibis, rats and feral cats to spread rubbish around. This is not appreciated by the PMRA members who participate in the Clean-up Campaign by picking up litter in the precinct.

It also increases the possibility of plastic bags and the like getting into the canals with potential danger to birds and dolphins.

Disposing of household rubbish in the street bins is illegal. It is considered to be littering. Residents who see people dumping household rubbish into street bins should provide details to the Ranger Service on 9550 3630.

Recycling Bins

There are some recyclable products that the City doesn't want us to put in our recycling bins.

In the "paper" group, items that can't be recycled include hard bound books, paper and cardboard contaminated with oil or grease, toilet tissue and paper towels. However, it should be noted that magazines can be recycled.

In the broad area of "plastics" the only recyclable items (as far as the City is concerned) are bottles with the triangular shaped recyclable symbol on them. Whilst some other plastic items are recyclable there is no market for the resulting product. As a result, residents should not put takeaway food containers, ice cream or yoghurt containers, plant pots, toys, plastic bags and plastic wrapping materials in their recycling bins. Non-packaging aluminium and steel items such as car parts, wire, cutlery, pots and pans should not be put in recycling bins. However, clean food cans and aerosol cans with the nozzles and plastic lids removed can be recycled.

The only glass items that can be recycled are bottles and jars (regardless of colour). Crockery, Pyrex, drinking glasses, reading glasses, window glass, windscreens, tiles, light bulbs and broken glass should not be placed in recycling bins.

Maintenance Items

And finally, the City is very responsive to reports of maintenance items such as fallen limbs, damaged retic, graffiti, dangerous footpaths, overgrown shrubs, etc. To report such items phone 95503747 or send an email to council@mandurah.wa.gov.au

A Vision for Sutton Farm

Following on from the debate in the Mandurah Mail about the future of Sutton Farm, local artist Marjorie Sharp is lobbying for the site to become an arts precinct. This is in response to the building application that has been submitted by the owner of the land, Cedar Woods, who want to build high-rise units around the heritage farm buildings. Understandably, there has been a great deal of opposition to these plans, and local residents would prefer the land to be developed along the lines of Edenvale in Pinjarra so that not only would the historic farm site be preserved for future generations, it would also be a draw for tourists.

Given its attractiveness, its cultural heritage significance and its beautiful canal-side location only a short walk from the Bridge Quarter, Marjorie believes that Sutton Farm should be made available to the community and could be a culturally enriching site where:

- Everyone from school children to retirees could visit
- Visitors and local people could view and purchase artists' work
- Teachers could teach arts and crafts, and hold workshops

A café would allow people to linger a while and enjoy their surroundings. "Sutton Farm would make a wonderful Arts Heart for Mandurah" says Marjorie. "It would bring joy to so many people and would be an icon in the community for all to visit".

Marjorie is currently in negotiations with Cedar Woods and the City of Mandurah and is collecting expressions of interest from local residents and artists who are enthusiastic about supporting her project.

Support for PMRA

Our local member of Parliament (Member for Dawesville) Dr Kim Hames is Deputy Premier, Minister for Health and Indigenous Affairs and as a result is a very busy man. However, he is also a keen fisherman and very involved in the local community. In recent times he has supported PMRA by:

1. Raising with the Minister for Water our concerns regarding the cost, time taken and the danger involved in delaying provision of a dredging licence.
2. Writing to the Minister for Transport regarding the inappropriate location of the navigation post in the Estuary at the northern entrance to the Port Mandurah canals, and
3. Supporting the replacement of the boat ramps at the Mary Street Lagoon with the Minister for Transport.

As a result of Dr Hames' intervention, the Minister for Water has advised that the Dept of Water has now acknowledged that there are no environmental issues with agitation dredging and that, as a result, future licence approvals should be able to be provided in 30 days. In addition, he suggested that the City could discuss with the D of W the possibility of obtaining a 5 year licence. These are major breakthroughs.

Regarding the navigation post the Minister for Transport promulgated a notice to mariners, installed temporary navigation buoys and brought the matter to the attention of the relevant officer in the City.

The D of T sets aside funds gathered from boat licences to provide facilities for recreational boating in a scheme known as the Recreational Boating Funding Scheme. However, it usually requires the local Council to provide at least half of the funds required. The City made a grant application for replacement ramps at the Mary St Lagoon and Dr Hames provided a letter of support.

We thank Dr Hames for his actions in these matters.

Administrator Required

Jill Randall has been the "backbone" of PMRA for the last five years. However, Jill has now resigned. New Committee member Linda Thorpe has volunteered to take over maintenance of the website and production of the newsletter. We now need someone to undertake the administration including, bookkeeping, etc.
